The *SDTools SARL* Software License Terms apply to your use of the software
Use of the Software indicates that you accept the *SDTools SARL* Software License Terms

IF YOU DO NOT ACCEPT THESE TERMS, YOU MAY NOT LEGALLY USE THE SOFTWARE.

IF YOU PURCHASED A LICENSE TO THE SOFTWARE FROM *SDTools SARL* OR A *SDTools* RESELLER, YOU MAY RETURN THE SOFTWARE FOR A FULL REFUND.

IF THE SOFTWARE IS SUPPLIED WITH ANOTHER PRODUCT, YOU MAY ALSO RETURN THE ENTIRE UNUSED PRODUCT FOR A FULL REFUND. YOUR RIGHT TO RETURN AND REFUND EXPIRES 30 DAYS AFTER PURCHASE FROM *SDTools* OR AN *SDTools* RESELLER. License Grant

SDTools SARL grants You a license to use one copy of the Software on any one hardware product only for Your internal operations.

"The Software" means the enclosed software program as updated, replaced or modified, and authorized for Your use by *SDTools*.

"You" means the company, entity or individual whose funds are used to pay the license fee.

"Use" means storing, loading, installing, executing or displaying the Software.

You may not modify the Software, disable any licensing or control features of the Software except as an intended programming feature of the Software.

If the Software is authorized for "concurrent use", only the number of users for whom You have paid the appropriate license fee may legally use the Software concurrently.

Software licensed to degree-granting educational institutions at *SDTools* educational discount are further restricted to use in connection with on-campus computing facilities that are solely in support of classroom instruction and research activities of student and teaching faculty. The right to use the software for commercial purposes is expressly excluded. Discounts for "classroom" use further exclude use for sponsored or unsponsored research.

The documentation provided for use in connection with the Software may be printed and or copied as reasonably required only for internal use by You directly related to Your operational use of the Software. Printing and/or copying for training purposes requires the prior written authorization from *SDTools*.

Ownership

The Software and the documentation are owned and copyrighted by *SDTools*. Your license confers no title or other ownership interest in the Software or the documentation and may not be construed as a sale of any right in the Software or the documentation. Except as expressly stated, this license does not grant You any rights to patents, copyrights, trade secrets, trademarks or any other rights, related to the Software and the documentation.

Copies and Adaptations

You may only make copies or adaptations of the Software for archival purposes, when copying or adaptation is an essential step in Your authorized use of the Software. You must reproduce all copyright and other notices in the Software on all authorized copies or adaptations. You may not copy the Software onto any bulletin board or similar system or provide access to the Software via a Web application, without procuring specific rights, to do so from *SDTools*. You may not make the Software available for use by third parties generally on a time-sharing basis.

No Disassembly or Decryption

Transfer

Your license will automatically terminate after any transfer of the Software. Upon transfer, You must deliver to the transferee the original and all complete, partial or electronically stored copies of the Software and the documentation. Any copies, remaining in your possession or control must be destroyed. The transferee must explicitly accept all of the Terms of this License as a condition to the transfer. *SDTools* must be notified in writing of any transfer.

Termination

Your license may be terminated upon written notice for a material breach or for failure to pay any amount due within 45 days after the due date. Upon termination You must immediately destroy the Software together with all copies, adaptations and merged in any form.

All provisions regarding indemnification, warranty, liability and limits thereon and protection of proprietary rights, shall survive termination of this License, as shall all provisions regarding payment of amounts due at the time of termination.

Export Requirements

You may not export the Software or any copy, or adaptation in violation of any applicable laws or regulations.

Taxes, Duties, Customs

Absent appropriate exemption certificate(s), You shall pay all taxes, duties, or customs, except for taxes based on the net income of *SDTools*.
